

What snowbirds need to know about travel insurance!

Snowbirds spending the winter in Florida have different insurance needs from Canadians taking a holiday for a week or two at a time.




Travel insurance for long periods is particularly tricky. The provisions differ significantly from shorter terms and the premiums can be quite high. So it pays to shop around. Websites like Kanetix.ca, CARP.ca and Snowbirds.org are good places to comparison shop. You can buy the coverage online or over the telephone.

For example, using the CARP online system I asked for a quote for four months coverage between November and March for a healthy couple, aged 65. It came in at \$2,131 which included \$5 million emergency coverage and covers other trips of up to 30 days throughout the year. There is also limited trip cancellation and trip interruption insurance.

This policy did not cover pre-existing heart and lung conditions not stable in the three months before the effective date of the policy.

The quote for the same couple with multiple health problems was \$3,393, about 60 per cent more. As well, the required period of medical stability for pre-existing conditions increased to 12 months.

Definitions of medical stability are very stringent.



Those with medical conditions which exclude them from standard policy coverage may be able to obtain a higher-priced policy with less onerous exclusions from CARP or another insurance broker

It is essential to be honest. If you do not fully understand the questions, ask for clarification from the insurance company or your doctor.

"If you forget to disclose something about your heart, but break your leg, the insurance provider may refuse the claim," Dave Minor, a vice president with TD Insurance.

"They could say if you had disclosed all the details up front, we would not even have granted this policy," he said.

It is also important to take a close look at your car policy and its out of country coverage. Contact your insurance company if you are planning to use your car for an extended vacation in the United States. Americans like to sue and U.S. awards are typically higher than in Canada.

Minor says most Canadian policies cover driving in the U.S., but if you are planning to drive to Mexico, or ship your car overseas, you will need extra coverage.

Car rentals for more than 30 days will probably not be fully covered either. So you may need to buy additional coverage through the rental company or your own insurer.

Coverage for a recreational vehicle is generally similar to an car. But if you are moving to the U.S. for several months and it will be your exclusive place of residence, Minor says additional coverage may be required. (Cont. pg 13)

Traditional Plum Pudding with brandy sauce

Ingredients: 120 g brown sugar 120 g suet, chopped or grated 120 g sultanas 120 g raisins, halved but

not chopped
60 g currants
60 g shredded mixed mixed candied peel
60 g plain flour
60 g breadcrumbs
30 g almonds
1 lemon, grated zest only
1 tsp grated nutmeg
1/2 tsp salt

150 ml milk 150 ml brandy

2 eggs

To decorate
handful bay leaves
handful redcurrants or cranberries
25 g sugar
egg whites, beaten

For the brandy sauce 100 g flour 100 g butter 500 ml milk 50 g caster sugar brandy, to taste

Method

1. Make the pudding a few days before serving. Butter a large pudding basin and coat a cloth with flour ready to cover the pudding. Set aside.

- 2. In a large mixing bowl, combine the brown sugar, suet, sultanas, raisins, currants, candied peel, flour, breadcrumbs, almonds, lemon zest, nutmeg and salt. Stir in the eggs, milk and brandy and mix well.
- 3. Place the mixture in the buttered pudding basing, cover with the floured cloth and secure tightly with string. Prepare a steamer with boiling water, add the pudding basin and cook at a gentle simmer for 5-6 hours, topping up the water level regularly.
- 4. On the day of serving, reheat the pudding by steaming it again for at least 2 hours.
- 5. To make the decorations, dust the bay leaves and fruit in sugar. Dip them individually into the beaten egg whites then set aside to harden.
- 6. Meanwhile, make the brandy sauce. Melt the butter in a saucepan. Add the flour and allow the mixture to simmer slowly for 2-3 minutes. Gradually add the milk and caster sugar, plus generous tablespoons of brandy depending on how strong you like the sauce. Gently bring to the boil, stirring all the time and cook for 4-5 minutes.
- 7. Turn the hot pudding out of the basin, decorate the top with the sugared bay and fruit and serve with the brandy sauce.







Four words out of the mouth of an octogenarian on the cusp of her next decade. A woman who has lived a long and adventurous life with no signs of her demise.

She will likely be one of many Canadians who will reach 100 years old, and by then the announcement will not be made by the local TV weatherman as it will not be anything out of the ordinary.

With all the media coverage about dying with dignity, we can't help but wonder what the future holds for us Zoomers.

Now, it is not my intent to wade into this timely and controversial debate except to say, we are all going to die. That is for certain

And because we baby boomers are used to having things our way, needless to say, we will have a choice when our time comes. To depart this earth in a time of our choosing in a peaceful and uneventful fashion without repercussions for those left behind. Of that I am certain, the Supreme Court appeal notwithstanding.

As someone who has spent her entire career in health care, it still baffles me why we are so afraid to talk about death.

As our friends and relatives are starting to leave us in their 60s, dying too young, we can't help but ponder on our own mortality.

Just like the above-mentioned octogenarian who has ample time to reflect on a colourful life – a life that started in England where she was born into privilege. A sheltered existence shattered by the assault of a world war where the pain of life reared its ugly head too soon.

No opportunity for a formal education but instead a new start in a promising, young country called Canada with a handsome Canadian husband and an uncertain future but a pocketful of dreams.

Then came a handful of children and some hard times. But she was blessed with perseverance and strength and an uncanny ability to roll with the punches and laugh at the same time. A modeling career and various jobs in the hospitality business. Her career ended with the Peace Arch News where she retired from the front office at age 69.

She, too, is a writer.

The quiet erasing of the daily score that leaves no mark

No memory unkind, no half-turned agony of soul. It is a healer. A layer on of hands.

An Understanding.

Deep into the heart, the clamor fades.

The lights are dim.

(from pg. 3) Finally, even if you plan to go south for the winter, make sure you are still meeting all of the coverage requirements for absentee residents under your Canadian house, condo or tenant's package. Otherwise, if the power goes off and your pipes freeze and break, you could arrive home to an uninsured mess.

Typically if no one is living in your home, you must arrange for someone to check the property every seven days to ensure the heating is still on. Otherwise you have to shut off the water supply and drain the pipes or connect the plumbing and heating system to a monitored alarm station providing 24 hour service.
