## **CARP BARRIE SENIOR COMMUNITY FUND (SCF)**

### **RULES AND GUIDELINES**

1. CARP Barrie Seniors Community Fund (SCF) was created in July 2021 to assist low-income seniors in Barrie and the Surrounding Areas by providing financial assistance from \$100.00 - \$500.00 per application. The CARP Barrie Seniors Community Fund is a separate entity from the CARP Barrie Chapter. It is funded separately and has its own Constitution and Governance.
2. This document defines the rules and guidelines around the SCF.
3. Barrie and Surrounding Area are defined as the towns and municipalities CARP Barrie Chapter members are drawn from. Visit [www.barriecarp.org/](http://www.barriecarp.org/) for a list of towns connected to Surrounding Areas. Seniors applying for financial assistance from the CARP Barrie Senior Community Fund do not have to be members of the CARP Barrie Chapter.
4. A low-income senior is defined as an individual 65 years of age and above who has an income level at or below the Ontario Guaranteed Income levels listed at <https://data.ontario.ca/dataset/ontario-guaranteed-annual-income-system-benefit-rates>
5. The guaranteed income levels (for seniors between 65 and 74 years old) are:
  - a. Amounts reported were \$1 ,861.81 monthly (\$22,341.72 annually) for single pensioners.
  - b. Amounts reported were \$1 ,437.69 monthly (\$17,252.28 annually) per person for qualified couples.
6. Your Income Level will be determined from a current income tax Notice of Assessment provided by the applicant or a determination from the SCF Application Review Subcommittee of the financial need.
7. Proof of age is required. A scanned copy of a Driver's License. Purple Card, Health Card or Passport is accepted.
8. Financial assistance of \$100.00 - \$500.00 can be applied for by seniors living on low-income who are having challenges with necessities (such as but not limited to: rent, food, medical needs, personal needs, veterinarian services, etc.)
9. If a senior couple need assistance of \$200 - \$1000, you can apply once on a joint basis for both seniors. Or each senior can apply for \$100.00 - \$500.00 for themselves.
10. Applications can be submitted at any time and not necessarily by the senior themselves. We will review applications on behalf of a senior or seniors that are submitted by family members, caregivers, community agencies, and non-profit organizations. All applications will be treated with the utmost privacy and confidentiality.

## **CARP BARRIE SENIORS COMMUNITY FUND APPLICATION REVIEW SUBCOMMITTEE**

All applications to CARP Barrie Seniors Community Fund (SCF) will be reviewed by CARP Barrie Chapter Application Review Subcommittee.

This Subcommittee will be composed of at least Five (5) volunteers chosen by CARP Barrie Chapter.

Funding can be awarded at any time.

Payment will be made in the form of a cheque, gift card, or gift certificate as determined by the Subcommittee at its sole discretion.

In reviewing applications, these guidelines will govern the process.

The Subcommittee will seek partnerships with agencies serving seniors — these agencies will provide value and reduce Subcommittee logistics because they already support seniors on low-incomes and have process(es) in place to ensure the need is real and the applicant's circumstances are confirmed as low-income. Funding requests need to be very specific — How much is needed, what it is needed for, and when is it needed by. By knowing this, it allows the Subcommittee Members to approach specific businesses and fulfill a successful application.

Only one application will be approved in a calendar year.

The Subcommittee Members **MUST** declare a Conflict of Interest (real or perceived) and recuse themselves from voting if they referred the Applicant or know the Applicant. When this occurs, the Subcommittee may use a "substitute" member who would then be able to vote.

Although we wish we could approve all applications received, we assess applications according to where the need is the greatest.
